

MEMORANDUM OF UNDERSTANDING BETWEEN NARESUAN UNIVERSITY, THAILAND AND CHANG GUNG UNIVERSITY, TAIWAN



In a mutual desire to promote further intercultural, educational, scientific and technological exchanges, Naresuan University, Thailand and Chang Gung University, Taiwan agree to the following framework of academic cooperation:

- 1. Under this memorandum of understanding, each institute will make an effort to promote the cooperation for mutual benefit in the following areas;
 - Promotion of joint research and educational activities;
 - Invitation to short-term visits of 1-2 faculty members and researchers for lectures, conferences, colloquia, and symposia or other academic activities;
 - Exchange of information and pertinent publication in 1-3 fields of interest to both universities;
 - Exchange of 1-4 faculty members, researchers and students for study and research. Other forms of cooperation may be established when agreed separately on each specific case.
- 2. The details on other necessary matters concerning the exchange of students are provided separately in the "Memorandum of Agreement for Student Exchange".
- 3. The fields of study are to be designated for each case, based on mutual interests. The conditions for employing the achieved results as well as arrangements for specific visits and exchanges should be endorsed by both universities on each specific case.
- 4. Both universities understand that all financial arrangements will depend upon availability of funds in each specific case, which may be collaboratively and/or separately sought by both universities.
- 5. This memorandum of understanding will become effective from the date of the signatures by the representatives of both universities and valid for the initial period of five years. The memorandum of understanding will be reviewed not less than six months prior to the natural termination of the current agreement and may be extended or renewed in mutual accordance. At any time, the terms of this agreement may be amended by mutual agreement in a written notice.
- 6. The memorandum of understanding may be terminated by either university with a six-month notice. No applications shall be considered after this notice; however, the universities will continue to fulfill their obligations with the accepted exchange students until the completion of their study plans.
- 7. The memorandum of understanding should be concluded in two original documents, both written in English language and being equally authentic.

MEMORANDUM OF AGREEMENT FOR STUDENT EXCHANGE BETWEEN NARESUAN UNIVERSITY, THAILAND AND CHANG GUNG UNIVERSITY, TAIWAN

Preamble

Chang Gung University (CGU), Taoyuan, Taiwan and Naresuan University (NU), Thailand have agreed for institutional student exchange in education and research. The primary objective is to promote interaction and collaboration between faculty and students of the two institutions through visit and exchange programs, carry out on a reciprocal basis. The relationship also aims at enhancing the technological, social and cultural relations of both countries/states/regions. This document presents a general framework for such a relationship and exchange. It also includes some specifically identified areas of cooperation, which may be updated from time to time.

About Chang Gung University (CGU)

Chang Gung University (CGU), having its campus at 259 Wen Hua 1st Road, Guishan District, Taoyuan City, 333 Taiwan, is a private research-type university and offers various undergraduate, postgraduate & doctoral programs.

About Naresuan University (NU)

Naresuan University (NU), having its campus at 99 Muang, Phitsanulok 65000, Thailand, is a comprehensive university living up to the public expectations in providing diverse, cutting-edge programs through 22 faculties, schools, colleges, and demonstration schools.

Scope of Cooperation

The following area of cooperation has been identified under this MoU.

- 1. The two parties agree to cooperate in running Undergraduate Student Exchange for research purposes. The visit of the student(s) must be approved by the professor(s) under whom the student will pursue the internship 4 months to 1 year or short term or training program for 2 weeks to 3 months.
- 2. The credits earned in the host university shall be transferred back to the home university. Upon completion, the students shall return to the home institute.

- 3. The number of students participating in the Undergraduate Student Exchange shall be no more than ten (10) students per year. This number may be changed with mutual consent.
- 4. The students who can participate in this program are undergraduate students who have complete at least three (3) years of study at their home institute.
- 5. The students from both universities who are working on their final projects (research) are allowed to stay in a laboratory at the host university under the superivision of the joint supervisor professor.
- 6. The students from both universities are allowed to use the facilities under the supervision of the authorized professor or laboratory assistant based on the agreement between the supervisor in their home university and the professor of the host university.

The areas of cooperation may be revised by mutual consent. However, specific programs may require separate agreements detailed out and documented as annexures to this MoU.

Intellectual Property

Each institution will adhere to the intellectual laws of its nation.

The Parties anticipate that this MoU will help developing a number of individual research projects and/or exchange programs involving sharing of personnel, research paper authorship and/or sponsorship. Prior to each project and/or program, the Parties will formally agree the collaboration of these implementation of activities as set forth in Scope of Cooperation and the rights and obligations, including but not limited to the ownership of IPR and the indemnification of IPR, between the Parties in writing. Individual project and/or program will be reviewed and approved by designated officers of the Parties.

Furthermore, if one institution receives any information from the partner under a clearly defined non-disclosure agreement, necessary and reasonable care will be taken to protect the intellectual property received.

Financing

The exchange student would pay the home university, and no tuition fee would be paid to host university. All travel costs shall be borne by the students or their home university. Students have the right to seek for financial supports from the professors. The supports should be discussed individually.

Relationship

Arrangement between the institutions is on a principal–to-principal basis and not to be deemed to constitute a joint venture, agency, a partnership, franchisor-franchisee or principal-agent or alike relationship under any circumstances, and neither party shall have any right to act or assume or create or transfer any obligation on behalf of or for or to other party.

Legal Status

This document is a statement of intent to foster genuine and mutually beneficial cooperation and is not legally binding on both the parties. Any disputes shall be resolved through mutual discussion.

Validity

This MoU is valid for five (5) years and becomes effective from the date it is signed by the partners. The partnership period may be extended by mutual consent. In case one partner wishes to terminate the MoU, intimation will have to be sent at least six months in advance. However, specific commitments made prior to such intimation shall be honored by both the partners.
